We have some important information to share about your retirement Plan. Please see the details below.

**Understanding the details**

**Automatic Enrollment Feature**

This notice advises you of certain rights and obligations you have under the Plan. The Plan includes an automatic enrollment feature. If you've already made a deferral election, including 0%, the new automatic enrollment feature will not change your contribution level. Your earlier election will continue to be followed until you make an update.

If you haven't made a deferral election, you will automatically be enrolled in the Plan. This means a percentage will be withheld from your pay and contributed to the Plan for your benefit. The automatic deferral percentage is:

1	4%
2	5%
3	6%
4	7%
5	8%
6	9%
7	10%

NOTE: You have the right to elect a different deferral amount. You can elect to defer more, less or even nothing. You may change your election at any time by visiting [nationwide.com/login](http://nationwide.com/login) or by calling 800-772-2182. Once you've updated your deferral amount, you will no longer be subject to the automatic deferral percentage.

**Qualified Default Investment Alternative (QDIA)**

You have the right to direct the investment of your assets in the Plan. If you have already given investment directions, your contributions will be allocated to your previously chosen investments. If you haven't already given investment directions to your employer, any contributions made or allocated to your account in the Plan will be invested in one of the following funds, the "default fund", based on your date of birth and the normal retirement age of your Plan:
